Brush and Tree Debris Clearing – Get A Head Start This Winter!

The next few months are a great time get low branches trimmed (minimum 6 ft. off the ground) and fallen trees and limbs cleared off your property, now that the leaves have fallen, and before the weeds and grass start growing up quickly with the fresh rains.

- Clearing heavy brush and limbs now will make clearing the grass and weeds in May a lot easier and quicker.
- Contractor availability should be better in winter.
- If you do it yourself, it's easier and safer to do this work in cool weather, plus you can spread out your green bin loads over a few months instead of trying to do it all in May.
